





Admission, Referral, and Discharge Frequencies for 3/1/2024 - 9/30/2024




The average number of admitted patients was 312 from March 2024 to September 2024. Data points show patient admissions fluctuating around the mean without clear trends.






Both the numbers of first-time and returning admitted patients experienced fluctuations around the average number before notably increasing in September 2024.
